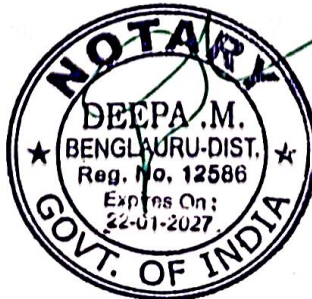

In connection with the above subject, the administrative board of **CHAITANYA KCS EDUCATION FOUNDATION**, through online submission, applied for the renewal of the **First School Recognition** for **DELHI WORLD PUBLIC SCHOOL, BANGALORE NORTH** DISE Code No. 29284101330 for classes **1 to 10**, English medium, at [address]. The documents submitted with the application were verified by the departmental authorities, and the **First Recognition** has been granted as detailed below.

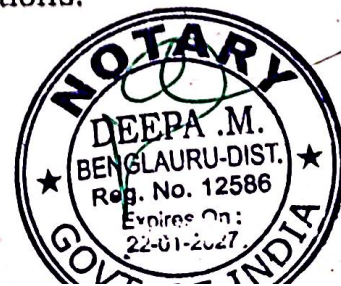

Conditions:

1. The school has been registered and its recognition renewed up to the classes for which it has been approved, in accordance with the Right of Children to Free and Compulsory Education Act, 2009 and the Karnataka Education Act, 1983, along with the rules framed there under. Conducting additional classes or sections beyond the approved ones is not permitted.
2. The school shall operate in accordance with the provisions of the *Karnataka Education Act, 1983* and the Right of Children to Free and Compulsory Education Act, 2009, and the rules framed there under.



3. Under the Right of Children to Free and Compulsory Education Act, 2009 and the rules framed there under, **25% of the seats shall be reserved for children belonging to weaker sections and disadvantaged groups.** Schools coming under the purview of the RTE Act are subject to the authority of the Government to admit students under this quota. [The Government has framed rules to ensure that children are admitted to **neighbourhood schools** near their place of residence. Accordingly, if there are **Government or Government-aided educational institutions** in the vicinity, children shall be admitted there.] If such schools are not available, **private schools** shall admit children assigned by the Government under the RTE quota and allow them to continue their education up to the **primary level.** These children shall be given the opportunity to continue their studies **without any discrimination.**
4. As described in Clause 3, the fees for children admitted under the RTE provisions shall be **released by the Government as per the rules.** Therefore, **collecting any fees from these children is strictly prohibited.**
5. The school and its management are **strictly prohibited from collecting any form of capitation fees or voluntary donations** from parents, either at the time of admission or at any time thereafter.
6. The school/management shall publish the details of the tuition fees collected from parents on the departmental website and on the school notice board, in accordance with the **State Government Notification No.: ED:31:VC:2019, dated 27.07.2019.** **Collecting fees beyond the prescribed amount is not permitted.**
7. The school/management shall admit students within the period prescribed by the Government.
8. The school/management shall not deny admission on the basis of the following factors:
(i) Due to lack of proof of age
(ii) On the basis of caste, religion, place of birth, or language
(iii) If admission is sought after the prescribed admission period
9. The school shall take all safety measures in accordance with the RTE Act and Rules and the Karnataka Education Act and Rules. [Including fire safety and building safety certificates from the concerned authorities, and ensuring the safety of children's learning as per K.S.C.P.C.R. and N.C.P.C.R.]
10. The school/management shall comply with the following:
(i) No child admitted to the school shall be held back in any class or expelled from the school until the completion of primary and secondary education.
(ii) No child shall be subjected to physical or mental harassment.
(iii) Until the completion of primary education, no child is required to pass any board examination.
(iv) Every child who completes primary education shall be issued a certificate as per RTE Rule 21 and the Karnataka Education Act and Rules.
(v) In accordance with the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules, the school shall also include children with special needs / children with disabilities.
(vi) Teachers appointed shall possess the minimum qualifications prescribed for primary and secondary school teachers under the RTE Act and Rules, the Karnataka Education Act and Rules, and relevant government orders.
(vii) The salaries, allowances, service rules, and conditions of service for teachers shall be as prescribed by the State Government. Salaries shall be paid through government notifications, [Provident Fund (PF)] and the designated banks and other salary disbursement methods. Employees shall also be covered under State Insurance (ESI).
(viii) Teachers shall perform the duties prescribed under Section 24[1] of the Act, the RTE Act and Rules, and Rule 17 of the Karnataka Education Act and Rules, and shall not engage in private tuition for supervisory considerations.



11. The school shall follow the integrated academic state curriculum and state textbooks.
12. As specified in Section 19 of the Karnataka Education Act, the school shall maintain rules and standards and appoint departmental staff as prescribed in the Karnataka Education Act and Rules.
13. The school buildings and other basic facilities shall not be used for any commercial activities, political activities, or non-educational activities, either during the day or at night.
14. The school shall not be run for the profit of any individual, group, or organization.
15. The school shall be audited by a Chartered Accountant, and a copy of the audit report shall be submitted to the Deputy Directors / District Education Officers by the end of June every year.
16. In accordance with the Government Notification [Kannada Language Policy 2016], the school shall follow the prescribed language policy.
17. The management and teachers shall perform their duties in accordance with the RTE Act and the Karnataka Education Act and Rules.
18. The school/management shall strictly follow the rules and directives issued by the Government and the Department.
19. It is mandatory to update the school information in the S.A.T.E.S system as per the rules by the end of March each year.
20. If the above conditions are violated, the recognition of the school shall be cancelled in accordance with the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
21. After the school recognition process is completed, the management shall allow the complete records/information submitted online in the application to be publicly viewed on the Department's website.
22. If the above conditions are violated, the recognition of the school shall be cancelled in accordance with the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.
